3. Finalization of Website Issue:

7. Preparation for AGM:

8. Election Procedure:

Discussion happened regarding the onward election to elect the office bearers during coming AGM as defined in society memorandum. Prof. M. S. Bhat (President) took the responsibility of preparatory work for the election.
